The following fees are covered by the Running Start Fee Waiver:

Technology Fee	\$4.00 per credit (minimum \$10, maximum \$40 per quarter)	The student body voted to assess this fee to provide email accounts, discounted Microsoft software, network storage, and regularly updated hardware and software.
Computer and Technology Fee	\$3.00 per credit (maximum \$30 per quarter)	This fee is charged in addition to tuition for classes that place a high demand on computer and/or technology resources.
Intensive Computer and Technology Lab	\$4.75 per credit (maximum \$47.50 per quarter)	This fee is charged in addition to tuition for classes that involve use of advanced technology or require extraordinary technical support.
eLearning, online	\$45 per course	For online and hybrid classes.
Quarterly Activity & Recreation Center Fee	\$6.67 per credit (maximum \$100.05 per quarter)	The Activity & Recreation Center is a joint effort between UWB and Cascadia students to provide space for student leadership and club, fitness and recreation, casual study, and a multi-purpose room/events center. This facility will be operated and used jointly by UWB and Cascadia students.
