## **Senior Staff Reports**

To be informative, yet mindful of your time, I have asked the senior staff to only share their top relevant items for your reading pleasure.

#### From the Vice President of Administrative Services, Terence Hsiao:

## **Information Services**

After a number of summer projects, the IS team is currently in maintenance mode focusing on supporting students and faculty in fall quarter. In October alone, 400 new Helpdesk tickets were created (81 of them for classroom related support – either non-functional A/V equipment or delivering additional technology for use in the classroom) and 436 tickets were closed/completed (66 of them related to classroom support). IS also provided weekly laptop/tablet checkouts to 18 different students totaling 32 equipment checkouts.

## **Facilities**

The Administrative Services team organized and presented the fall quarter Cascadia College Day for Inquiry and Assembly (DIA) on November 1<sup>st</sup>. The day consisted of a simulated emergency situation that required the attendees to engage in an Emergency Operations Center (EOC). This was an interactive event which allowed faculty and staff to experience possible emergency situations and how to manage the incidents through the Incident Command System and the use of an EOC. Feedback from attendees indicate a need for continued training in emergency preparedness and incident management.

## ctcLink Project and Activities

Although challenged in completing several events, SBCTC remains on track to request restart approval in mid-December 2017. FirstLink college remediation is taking longer than anticipated with the added requirements to complete fiscal year-end closeouts for both 2015-2016 and 2016-2017; expected completion is December. The ctcLink Project Director presented an amended college deployment schedule to WACTC in late October which reduced the total number of deployments by increasing the number of colleges per deployment, this in turn shortened the overall deployment schedule by six months.

In early November WACTC will review and approve the new project resource investment plan covering estimated budgets for software changes and additional staffing requirements at the State Board to ensure successful project implementation and post go-live support. Cascadia's project management team and staff's focus is on analyzing the project schedule to determine staff capability and resource requirements, then to develop a staffing plan and present deployment group option recommendations to Cascadia's Steering Committee. The staff attended one common process workshop in October and are preparing for participation in six additional workshops in November and December.

#### From the Vice President of Student Learning and Success, Dr. Rosemary Sutton:

We are in the middle of the fall quarter and Cascadia Faculty excels at teaching and participating in innovative projects.

#### Faculty Updates

 Eight faculty members attended the Washington Association for the Education of Speakers of Other Languages (WAESOL) conference on October 22<sup>nd</sup>. Emily Dvorak and Anne Tuominen presented "Integrate It: English Learning through Interdisciplinary Environments." Alex Schiff-Bellabiod, Lia Preftes, and Nataliya



Husar presented "Promoting Diversity and Gender Equity through ELP Novel Reading." Jessica Weimer was nominated for WAESOL member-at-large.

- Faculty member Gail Alexander and Dean Erik Tingelstad participated in the ATE • Mentorlinks meeting October 22<sup>nd</sup> and 23<sup>rd</sup> in Washington DC. It was the beginning of a multiyear project for the ETSP program in which Cascadia staff and their mentor, Roger Ebagge of Lane Community College, will work to redefine Cascadia's two year program.
- Faculty members Nano Tellez, Srividhya Venkatraman and Mohandas Raj attended the Pathways to Calculus workshop on October 25<sup>th</sup> at the University of Washington. The event was coordinated by a partnership between the SBCTC and the Dana Center at the University of Texas, Austin.
- Cascadia sent a team of math faculty and staff to participate in the Dana Center's Designing • Math Pathways (DMP) workshop October 26<sup>th</sup> in Seattle. The statewide workshop's purpose was to support institutional teams to develop and implement math pathways on a broader scale. Cascadia team members included faculty members Megan Luce, Cynthia Bea, and Nano Tellez. In addition, Anna Stufano from Advising and Dean Erik Tingelstad attended.
- Cascadia Faculty, Jared Leising, Sarah Zale, Brent Schaeffer, Louise Spiegler and Natalie Serianni gave a reading at Soulfood Coffee house in Redmond on October 19<sup>th</sup>. It was a fantastic event with a packed audience.
- Garth Neufeld has been working on a teaching-focused podcast project, "PsychSessions: Conversations about Teaching N'Stuff." It is available on iTunes or through the website Psychsessionspodcast.libsyn.com/website or https://goo.gl/QbhQbg

## College Updates

- Gordon Dutrisac and Anna Stufano (from Advising), Todd Lundberg (SL Dean), and Anne Tuominen (Instructional Designer) presented "STAQing the Deck" (a program we are offering in our COLL 101 courses) to the National Academic Advising Association (NACADA) in St. Louis.
- Nearly 300 students, faculty and staff from Cascadia and UWB attended a screening of "An inconvenient sequel: Truth to Power"

followed by a live screened Q&A with Al Gore on October 26<sup>th</sup>. The event was hosted in Mobius Hall via a partnership effort between the Campus Library, CSG, Cascadia and UWB Sustainability Clubs and Sustainability Offices.

- Jodie Galvan, Assistant Director of Sustainable Practices, will give two presentations this fall to promote the BAS in Sustainable Practices program: 1) "Providing Undergraduate Research Opportunities on Campus" will be presented at the SBCTC Baccalaureate Conference on November 14<sup>th</sup>; and 2) "Washington State Applied Baccalaureate Degrees – Overcoming Barriers to Careers in Sustainability for Working Adults, Low-Income Students, First Generation Students, and Students of Color" will be presented at the King County ECO Net Summit on December 6<sup>th</sup>.
- iUrban Teen is a STEM education program that encourages STEM careers for youth • (predominantly male youth of color ages 13-18). We welcomed over 100 visitors to campus



on Saturday, October 28<sup>th</sup> for STEM-O-Ween that included STEM workshops and other interactive education forums. Three Cascadia faculty/staff lead workshops: **Craig Duckett** (Karel the Robot – computer programming); **Mohan Raj** (Egg Drop – engineering); and **Jodie Galvan** (Parking planning with Google Earth & iMap).

- Student Success Services hosted a Gender Identity 101 Training for staff and student leaders to help further our understanding and develop ways in which we can better serve students.
- Five staff from Student Success Services and three faculty are attending the Washington Faculty and Staff of Color Conference in Vancouver, WA.
- Cascadia is hosting the first session in our College Goal Cascadia program on November 4<sup>th</sup>. This session will help students and families complete the financial aid application (FAFSA).
- During November, Student Advising & Support Services are offering two Transfer 101 workshops and also are partnering with Evergreen Hospital on a Nursing Information workshop for students interested in the nursing profession.

## From the Vice President of College Relations and Advancement, Ms. Meagan Walker:

#### **External Relations**

Student Recruiting

- In September, prospective student recruiting focuses on educating the high school counselors. Cascadia/UW Bothell hosted a fall counselor workshop on campus and attended a second counselor workshop in Seattle. These are attended by hundreds of counselors who advise seniors about their post-graduation options. The combined outreach for these two events totaled more than 150.
- Cascadia also attended its first college fair of the season, presenting to prospective students and their parents at Cedarcrest High School in Duvall. Approximately 40 people learned about our programs at this event.
- We held multiple Fast Track Sessions and campus tours, helping to move the last of the fall quarter prospective students through the application process.
- Outreach has 23 recruiting events on the calendar for October.
- Launched SnapChat campaign to engage students to participate in Cascadia's newest social media platform.

## Campus Outreach

- Produced student success stories video for employee convocation.
- Organized and hosted the first event of the year for Mo, our mobile trailer. More than 300 students and staff stopped by the trailer to get cookies and lemonade, ask questions, and tour the trailer during the first two days of fall quarter.

## **International Programs**

Fall Quarter Enrollment

- A total of 257 students enrolled in university transfer program (vs. 254 for fall quarter 2016)
- A total of 130 enrolled in English Language program (vs. 168 for fall quarter 2016)
- International Programs enrolled 100 new students in fall quarter with 38 in university transfer and 62 in ELP (see country list below). In fall quarter 2016, we enrolled 102 new students for fall quarter with 36 in university transfer and 66 in ELP.

## From the Executive Director of Human Resources, Martin Logan:

## Human Resources

HR completed the **Quarterly Associate Faculty Benefit Process**, assessing 100+ Associate Faculty's FTE (class load) system-wide regarding if they gain or lose the Public Employees Benefits Board Health Care Authority benefits (medical, vision, dental, life insurance and long term disability insurance) and retirement benefits at Cascadia. At this point we have approximately 74% of our part time Associate Faculty covered under benefits.

The HR team is now managing the **Annual Open Enrollment** process for all Classified, Exempt and benefits-eligible Faculty which runs from November 1–30, 2017. Most changes can be done easily through the Health Care Authority's online portal and will be effective January 1, 2018. For more information, look to the weekly e-mail notices during the 5-week Open Enrollment period from either Haley Green or Katherine Kameron, HR Generalists.

The HR/Payroll Office -- with Shawn Stephens, Sr. Admin Assistant, taking the lead -- facilitated the college-wide **Annual Flu Clinic** on October 19<sup>th</sup>. Thirty-four (34) Faculty, Staff and Students participated. Feedback was that it was run smoothly with very little wait time.

Our Executive Director of HR, Martin Logan, introduced an anonymous **HR/Payroll Satisfaction Survey** to the campus. Currently 82% of the 55 participants stated that HR/Payroll either meets or exceeds their expectations of service. We will continue this satisfaction survey via a link at the bottom of all HR/Payroll team members' e-mail. We welcome your feedback and suggestions for improvement!

Finally, HR and Payroll would like to congratulate and thank **Rod Cowley**, **Payroll Manager**, for his **11 years of service** here at Cascadia.

#### 2018 Transforming Lives Nomination

Every year the ACT (Trustees Association) requests one student nomination from each college to attend the Transforming Lives Awards Dinner in Olympia during the ACT Winter Conference held in January.

The trustees were emailed the nomination of LaShanta Sealy prior to this meeting. The Board of Trustees approved and voted upon the nomination of LaShanta Sealy to represent Cascadia College at the Transforming Lives Awards Dinner on Monday, January 22, 2018 in Olympia.

Chair Janet McDaniel asked for a motion to approve the nomination of LaShanta Sealy for the Transforming Lives Award on behalf of Cascadia College. Trustee Nancee Hofmeister made a motion to approve the nomination and Trustee Roy Captain seconded the motion. Hearing no objections the nomination of LaShanta Sealy was approved.

## Acceptance of Gift and Naming of Bock Center

For the first time in the College's history, we have an opportunity to accept a gift and name a facility after a long-standing benefactor. John and Margaret Bock established a scholarship endowment in 2007 with a gift of \$107,000; the first awards were distributed in 2008. Over the last 10 years Ms. Bock continued to make generous donations to the endowment. Upon her death last year, a portion of her estate was entrusted to Cascadia for the endowment.

In honor of the Bock's generosity, the college's executive team and the Foundation Board recommends to the Board that:

1. The college officially accept the 2017 bequest of \$570,000 bringing the value of the Bock endowment to \$885,000.

Chair Janet McDaniel asked for a motion to officially accept the 2017 Bock Bequest of \$570,000 on behalf of the Cascadia College Foundation. Trustee Mike Kelly made a motion to accept the gift and Trustee Nancee Hofmeister seconded the motion. Hearing no objections the 2017 Bock Bequest of \$570,000 on behalf of the Cascadia College Foundation was accepted.

2. The college name the institution's learning center (currently located in CC2) as the John & Margaret Bock Learning Center, or simply the Bock Center.

President Murray reminded the Board that Policy BP8: 4.10 gives the Board authority to name such facilities, areas or events in honor of an individual, family, group, business, corporation etc. Dr. Murray suggested the Board approve a formal resolution on the naming the Bock Center at the November 15, 2017 board meeting. The trustees agreed and will take final action on the naming of the Bock Center at the next meeting via formal resolution.

#### Cascadia College Foundation Amended Articles

In July 2017, the Cascadia College Foundation Board of Directors completed a comprehensive legal review and restatement of its Articles of Incorporation. The changes did not alter the Foundation's purpose or mission. The agreement between the College and the Foundation prohibits the Foundation from changing its Articles without written consent of the College's Board of Trustees. The Trustees were asked to review the amendment and restatement to the Foundation's Articles of Incorporation.

Chair Janet McDaniel asked for a motion to accept the amended articles. Trustee Nancee Hofmeister made a motion to accept the Cascadia College Foundation Articles of Incorporation as presented and Trustee Roy Captain seconded the motion. Hearing no objections the Cascadia College Foundation Amended Articles were approved.

#### Strategic Plan Indicator 5A-1C – Master Plan Update

Meagan Walker, VP of College Relations and Advancement gave the Board an update on the Campus Master Plan approval schedule. The Campus Master Plan must be approved by the Bothell City Council, the University of Washington Regents, and the Cascadia College Board of Trustees.

Ms. Walker recommended that the Board review the draft campus master plan in this meeting, have an open discussion in the November 15<sup>th</sup> board meeting, and take action and final adoption in the January 17, 2018 board meeting.

Special guests Jennifer Phillips, City Manager for the City of Bothell and Kelly Snyder, Assistant Vice Chancellor, UWB were present and along with Ms. Walker, they answered questions the Board members raised on the Campus Master Plan.

Ms. Walker also shared a draft 2017 Campus Master Plan – Partnering Commitments report with the Board which gave them more information on partner activities.

Martin Logan, Executive Director of Human Resources shared with the Board that Title IX issues among local colleges and universities have become increasingly controversial and complicated.

Cascadia has a good foundation in place as far as employees with backgrounds and understanding in this area. The majority of Cascadia's Directors in Student Services as well as staff in the Human Resources Office have attended extensive training on Title IX.

The next step is to formalize Cascadia's procedure so the college can effectively coordinate its efforts as problems arise. Assistant Attorney General, Alan Smith worked closely with the college to finalize the procedure being presented to the Board at this time.

It is recommended that the Board of Trustees vote and approve the Title IX Procedure titled "Discrimination Complaint Procedure".

Chair Janet McDaniel asked for a motion to approve the Discrimination Complaint Procedure as presented. Trustee Roy Captain made a motion to approve the procedure and Trustee Mike Kelly seconded the motion. Hearing no objections the Title IX Procedure title "Discrimination Complaint Procedure" was approved.

#### 10. REPORTS

<u>Cascadia Student Government Report:</u> CSG President Cassie Rudolph submitted a report that was included in the Board packet. Ms. Rudolph was present and commented to the Board that a few students were at the City Council Meeting testifying on behalf of the Campus Master Plan. She also shared that recently, the students held an involvement fair to get students connected to the different clubs on campus.

<u>Cascadia College Classified Union Washington Public Employees Association (WPEA) Report:</u> Marah Selves noted in the Board packet that there was nothing to report this month on WPEA activities. Marah was not present at the meeting.

<u>Chair and Individual Board Members Reports:</u> No reports were given from the Chair, Vice Chair or trustees.

## President's Report:

President Murray handed out a flyer announcing the Cascadia College/UW Bothell Ride Glide Drive Program to assist commuting to campus. Commuter services began operating the "Truly Express Shuttle Service" which will run from 7:00 am until 10:50 pm every Monday through Thursday. The schedule is posted on websites and students can download the live shuttle app to track the Truly Express. The campus parking spots are clearly labeled and a pay station has been installed.

President Murray handed out the Corporate & Continuing Education Center Business & Industry Solution Newsletter – Eastside Edition to give the Board more information on this valuable partnership.

President Murray shared an invitation from students to invite the Board to the Community & Technical College Student Legislative Networking Reception to be held on November 17, 2017 at 7:30 pm at the Hotel Red Lion in Olympia.

President Murray commented to the Board that he will be in Olympia more this legislative session to bring Statewide Legislative Requests to the attention of the legislators from Cascadia's districts.

#### **11. OTHER BUSINESS/ANNOUNCEMENTS**

President Murray thanked the outgoing chair, Mr. Mike Kelly for his year as Board Chair. Mr. Kelly stated it was his pleasure fulfilling this role and it felt very natural. He thanked the college for this honor and stated it was a rewarding experience.

President Murray and the Board congratulated Trustee and new Board Chair Ms. Janet McDaniel for her reappointment as a Cascadia College Trustee. It was announced that her new term will go through September 30, 2022.

President Murray reminded the Board that the November 15<sup>th</sup> Board meeting will be from 4-6 pm with the Cascadia College Foundation Bock Reception to follow from 6-7:30 pm. He hoped all Trustees would be able to attend the reception.

## Subject: Naming of the John and Margaret Bock Learning Center

## Background

For the first time in the College's history, we have the opportunity to name a facility after a long-standing benefactor.

Shortly after marrying in 1949, John and Margaret Bock moved to the Totem Lake area. John was a salesman and Margaret a homemaker. In the late 1960's when the extension of Interstate 405 was slated to run through their property, they sold their home and moved east beyond Redmond.

Before John's death some twenty years ago, the Bocks talked frequently of sharing their good fortune with a student or students seeking a college education. Ms. Bock made a commitment to honor that vision. Although the Bocks did not have children of their own, Ms. Bock decided to establish the endowed scholarship to help Cascadia students reach their dreams. The endowment supports students who demonstrate academic success and are pursuing a degree in the sciences, math, or economics. The endowment has funded multiple scholarships to date.

Ms. Bock established the endowment in 2007 with a gift of \$107,000; the first awards were distributed in 2008. Over the last 10 years, Ms. Bock continued to make generous donations. Upon her death last year, a portion of her estate was entrusted to Cascadia. Creating the endowment, especially one of such significant size, has and will fund dozens of student scholarships each year for generations.

At the October 18<sup>th</sup> Board meeting, the College officially accepted the 2017 bequest of \$570,000 bringing the value of the Bock endowment to \$885,000.

# Action

In honor of the Bock's generosity, the college's executive team and the Foundation Board recommend to the Cascadia Board of Trustees that Resolution 11-15-17 be signed to formally agree that:

• The college name the institution's learning center (currently located in CC2) as the John & Margaret Bock Learning Center, or simply the <u>Bock Center</u>.

• Authority to do so is reflected in Board Policy BP8: 4.10 where the Board of trustees shall take final action on the naming of such facilities, areas or events in honor of an individual, family, group, business, corporation etc.

The Bock's desire to help students learn and achieve their goals is best represented by naming the learning center facility after them. The learning center continues to grow as a vital resource to students' success with quality professional staff, tutors, and services. It is an integral facility for Cascadia and will continue to grow and expand in importance as the college itself grows.
