#### From the Vice President for Administrative Services, Sean Poellnitz:

#### **FACILITIES**

- Cascadia presented the CC5 project to budget writing legislative staff as well as SBCTC capital projects manager. This presentation helped answer questions from the legislators regarding the project and need for the building.
- The Facilities team and Emergency manager attended Enterprise Risk Management training in collaboration with our partners at UWB.
- Reviewed and updated Standard 2 items for Accreditation review
- Started onboarding of new Facilities Program Coordinator, Jack Torres Zuniga

#### **FINANCE**

- The Team is updating and reviewing several department policies and procedures as it relates to Standard
   2 for Accreditation.
- The team reviewed our account needs with US Bank to determine the most cost-efficient programs for the College to use in relation to credit cards, wire transfers, etc.
- Finance and Facilities are working together to update the asset inventory which includes all furniture and science lab equipment

#### **HUMAN RESOURCES, COMPLIANCE AND PAYROLL**

- This month, HR focused on advancing organizational effectiveness, employee support, and institutional compliance. Open Enrollment was successfully launched, with benefits finalized for newly eligible employees, ensuring staff have access to appropriate resources and coverage.
- HR supported the onboarding of new staff, including the Facilities Program Coordinator, and welcomed
  new student employees to the HR team, strengthening workforce readiness and engagement. Active
  FMLA and accommodation requests were managed to provide timely and equitable support for
  employees. In addition, HR prepared exhibits and documentation to support accreditation readiness,
  ensuring that institutional records and processes meet required standards.

#### **INFORMATION TECHNOLOGY SERVICES**

ITS successfully completed a comprehensive enhancement of Cascadia's student account creation
process. Notable updates include improved communications regarding campus technology which was
developed in partnership with Outreach & Student Onboarding, the rebranding of the account as the
Kodiak Account, and the simplification of the student username. The primary purpose of this project was
to make accessing Cascadia's technology resources easier for students, ensuring they can engage
seamlessly with campus tools and services.

#### From the Leadership Team for Student Learning, Dr. Erik Tingelstad & Shannon Bath:

#### Recognition

We are excited that Kelly Leahy and Gordon Dutrisac were selected as Fellows for the Middle Leadership Academy, a systemwide professional learning initiative designed to strengthen the leadership pipeline across Washington's 34 community and technical colleges. Grounded in equity, student-centered transformation, and the core principles of Guided Pathways, the academy is designed to equip participants with the knowledge and leadership skills to advance these pillars in practice through institutional reform, cross-functional collaboration, and equity-centered action. In June they will present in teams at the statewide virtual showcase highlighting innovative, equity-driven Guided Pathways strategies.

#### **Dual credit – College in the High School**

Megan Luce, Math faculty, attended the annual NACEP (National Association of Concurrent Enrollment Programs) in Los Angeles at the end of October. This included the Accreditation Standards Institute on October 26<sup>th</sup>, a required step in Cascadia's movement toward future accreditation with NACEP.

#### **Application Development**

Faculty member Brian Bansenauer, attended the 2<sup>nd</sup> year meeting of his Mentorlink grant project held in Washington, C on October 27 and 28. The meeting time coincides with the annual Advancing Technical Education (ATE) conference.

#### **Water Resource Management Updates**

The Technical Advisory Committee (TAC) for the Water Resource Management Program fall meeting was Tuesday, November 4th. The committee welcomed five new members:

#### Inclusion and Advocacy Center -

Our work in the Diversity and Equity Center continues to go well. Over the last two week we had the following, successful events:

We continue with our campus connections and attended library events; Mobius Art Gallery, and the Native American Luncheon. Our campus connections have been helpful to support both our employees and students.

#### Cascadia Scholars -

- We currently have 100+ Scholars. We completed several rounds of application reviews and have concluded this year's application cycled.
- We currently have 24 mentors and will use winter term to recruit and train up to 10 new mentors.
- We have also been able to promote the Cascadia Scholars Program with classroom visits of COLL 101 courses and during both the Involvement and Resource Fairs.
- We hosted two Cascadia Scholars Orientation sessions and have completed our mentor assignments.
- We are working with Cascadia Foundations on prospects for our Scholars that include job shadowing and internship programs. We are excited to expand on the opportunities we can offer our Scholars.

#### 1. Public Meeting Call to Order

Chair Dr. Meghan Quint officially called the regular meeting of the Cascadia College Board of Trustees to order at 4:00pm.

#### 2. Consent Agenda

Chair Quint presented the Consent Agendas for approval. No modifications were proposed.

The Board welcomed the new employees and expressed appreciation for their commitment to student success.

#### 5. Information Item

#### A. Strategic Plan Update

One of the Trustees' responsibilities is to assure mission fulfillment, in part by staying abreast of the college's Strategic Plan initiatives.

President Murray guided trustees through the 2025-26 active Strategic Plan initiatives presentation included in the meeting packet. Trustees expressed appreciation for the improved format.

#### 6. Discussion & Presentation Items

#### A. Mission Fulfillment Moment: Peer and National Comparisons

President Murray reviewed updates on the accreditation progress. He highlighted three recommendations from the 2020 NWCCU review:

- Improving Institutional Effectiveness
- Student learning
- Student Achievement

Michael Horn joined virtually to discuss national comparison data (HEDS).

#### Topics included:

- Fall-to-Winter Retention Rates and Washington peer comparisons
- UW Bothell yield rate data
- NWCCU recommendations and progress
- Ongoing efforts to remove barriers and improve effectiveness

#### B. 10th Day Enrollment and Financial Forecast

Each quarter the Board of Trustees reviews the enrollment as of the 10th day for changes in patterns and impact to budget.

VP Blakeney reviewed the Full Time Equivalency (FTE) Enrollment Data.

VP Poellnitz distributed updated financial forecast reports and discussed early-year budget projections.

President Murray emphasized a goal of maintaining financial discipline while preserving healthy reserves.

The BOT Finance Subcommittee will convene before February to review ongoing fiscal strategies.

#### C. Cybersecurity Update

VP Poellnitz presented the annual Cybersecurity Assessment & Threat Strategy Report. Highlights included:

- Zero major breaches in the past year
- Ongoing updates and system maintenance
- Continued leadership by IT Services in proactive defense measures

Trustee Quadri inquired about software patching status; Sean confirmed all systems are current and will provide more detailed information on this matter.

#### D. Year-in-Review: Marketing & Communications

Executive Director Meagan Walker presented a summary of 2024–25 initiatives:

- New brand standards and two promotional videos completed
- **Enrollment campaigns**, general and professional-technical, through YouTube, Meta, Google, and mailers
- **Strengthened crisis, external, and internal communications** (including GoCascadia home page relaunch)
- **Expanded creative services** in design, video, and photography

Trustee Ponto inquired about AI's impact; Meagan shared that AI tools have improved efficiency in design and content creation.

#### E. Year-in-Review: Foundation

Executive Director Brittany Caldwell reviewed Foundation achievements from their Strategic Plan:

- Strengthened **board membership**, including Cascadia alumni
- Successful **fundraising** through major events:
  - Scholarship Reception
  - o 25th Anniversary Celebration ("Pay It Forward" raised over \$75K)
  - o Rose Revival...and Cool White Wines
- Expanded community outreach and partnerships, including the President's Advisory Council and Alumni Engagement
- Awarded 188 Scholarships in 2024-25, and added new scholarships
- Reviewed budget and program funding allocations

One of the college's three recommendations at the NWCCU mid-cycle review was to assure ongoing and systematic evaluation and planning processes were in place to inform decision making and resource allocation (see <a href="below">below</a>). #### Student Achievement



# Personal Outreach

- ESL faculty wanted study resources more accessible to ESL evening students.
- Bock Learning Center stayed open until 6:00 pm, staff invited ESL students to the Center.
- Data: evening BLC use went from 0 to 47 visits!
- Lesson: approaching ESL students between 5–6pm works to get them into the BLC.
- Lesson: Personal outreach overcame students' language and confidence barriers.




# College Career Foundations

- Data: 13% of all CCF students take at least one college-level class
- Data: Of those students, 31% earned an associate degree
- Action: A new academic advisor has been hired specifically to assist students in the transition from CCF to degree pathways
- Action: Students are advised to take ENGL 101 early



# Redmond Town Center

- Data: most students attended RTC to suppliment their main campus enrollment. ESL was popular.
- Lesson: district leaders enthusiasim did not translate into high school students at RTC.
- Action: added more ESL to meet demand.
- Action: reduced day-time class offerings
- Next steps: meetings are planned with HS principals to see what can be improved.



# Academic Plan Mapping

- Advising tested an appointment reminder process to increase the number of students who "find a path".
- Data: tracked # of students who received a personalized message, how many clicked the link, how many booked an appointment.
- Data: more test students scheduled and attended appointments and had fewer no-shows, than the control group.
- Next Step: This method will become part of standard work, where all advisors use the Navigate alert feature



### Senior Priority Hire

In negotiations for our 2025-2028 CBA, we approved a new status and pay increase for Associate Faculty members who have had Priority Hire status (Senior Priority Hire) for a minimum of five years. Due to some missed communication (and less-than-perfect oversight/review of the new CBA by the CCCFT Coordinator), the pay increase was not instituted on July 1, 2025, as per the collective bargaining agreement.

However, thanks to the work of Teya Viola, Ana Benitez, and Shannon Bath (with assistance from the Joint Contract Administration Committee (JCAC)), the matter was dealt with quickly and efficiently. Eligible Senior Priority Hire faculty will receive their retroactive pay from summer quarter, and all Senior Priority Hire faculty will be receiving their negotiated rate going forward. This is another example of the collaborate, solution-oriented climate that we have established between CCCFT and the College; many thanks to those who addressed this matter in such a positive manner.

### ❖ AFT and CCCFT support for students and families in need

AFT members continue to work together locally and nationally to help meet the needs of students and families who are affected by the Federal government shutdown and the suspension of SNAP benefits. Raising money, volunteering at food banks, supporting our campus food pantry are just some of the ways we demonstrate our commitment to the health, safety, and educational opportunities of students and families here in Washington state and around the country. To that end, CCCFT has donated \$500 to the Kodiak Cave food pantry. (Here's hoping that by the time this report is presented at the November Board Meeting that the shutdown has ended.)
