

1. Apply for your Veterans Educational Benefits.

Fill out appropriate application at

<https://www.va.gov/education/about-gi-bill-benefits/>

Print a copy of your application and bring to the VA Orientation. If you already have a Certificate of Eligibility, (COE) please bring that with you.

If you have a COE but cannot access it, log into or create an account with E-Benefits via <https://www.ebenefits.va.gov/ebenefits/homepage> print it and bring it with you.

If you are transferring your benefits from another educational institution, please be advised that you must resubmit all VA documentation to Cascadia, as requested, to start your file and begin using benefits here.

2. Apply for Admissions to Cascadia online at <https://apply.ctc.edu/user>.

3. Schedule a Veterans Orientation by filling out the [online Academic Advising Appointment Request Form](#).

4. Submit the following paperwork for the Veterans Orientation.

- DD214 Member 4 copy
- COE Certificate of Eligibility
- *Chapter 35 Students Only – VA 100% Disability Letter*

5. Submit official transcripts from prior colleges and official military transcripts (Joint Services Transcript or Air Force Transcript).

- **Army, Coast Guard, Marines, Navy** transcripts from <https://jst.doded.mil/jst/>
- **Air Force** transcripts call (334) 649-5066 or DSN 749-5066 or online order from <https://www.airuniversity.af.edu/Barnes/CCAF/Display/Article/803247/community-college-of-the-air-force-transcripts/>
- The official transcripts may be sent electronically directly from your previous institution or mailed to:

6. **Complete the [online Transcript Evaluation Request Form](#)** to evaluate official transcripts and transfer eligible credits to Cascadia.
7. **Complete the Tuition Waiver Form on [Cascadia's Veterans webpage](#).**
 - Tuition Waiver for Eligible Veterans or National Guard Member**OR**
 - Tuition Waiver for Child or Spouse of Totally Disabled, POW, MIA or Deceased Eligible Veteran or National Guard Member
8. **Establish English and math placement.** Visit the [Admissions webpage](#) for more information on placement options including Accuplacer and to ensure the classes you take match your skills, needs, and goals.
9. **Apply for Financial Aid** – *not required, but recommended.* Visit the [How to Apply webpage](#) to view your options and steps to apply for financial aid.
10. **Attend the Veterans Orientation.** At the Veterans Orientation, you will meet with the Veterans Academic Advisor, review eligible veterans educational benefits, register for classes, and learn about campus resources.
11. **Complete the [online Quarterly Form](#)** (every quarter that you wish to utilize educational benefits).
